Sub : Universalisation of Scheme for Adolescent Girls (SAG) and revision of cost norms for supplementary Nutrition(SN) under the Scheme for Adolescent Girls (SAG) of Umbralla ICDS Scheme.

Sir,

I am to state that the Governor has been pleased to allow this Department to implement the Scheme for Adolescent Girls (SAG) throughout the State as a sub-component of Umbrella ICDS Scheme keeping in view of the schematic guidelines issued by MWCD in their letter no. 11012/3/2017 – O/O ADSABLA on 02.04.2018 for the targeted beneficiaries of out-of-school Adolescent Girls in the age group of 11-14 years only.

I am also to state that the Governor has been pleased to revise the rates of supplementary Nutrition and non-nutrition components under this Scheme for Adolescent Girls as given in the table below:

Service	Category	Existing Rate	Revised Rate
Nutrition	Adolescent Girls(out of School 11-14 Years)	Rs.5.00 per day per beneficiary for 300 days in a Financial Year	Rs.9.50 per day per beneficiary for 300 days in a Financial Year
Non-Nutrition	Each ICDS Project of total 575 Project		Rs.1.10 Lakh per Project per Year.

The beneficiaries will be provided with Ready-to-Eat food to ensure provisioning of recommended quantity of energy and Protein to each beneficiary for 300 days in a year in the form of Take Home Ration (THR) on weekly basis.


Cost of Supplementary Nutrition and non-nutrition Component will be meet from the following Head of Accounts with the cost sharing between Govt. of India and State Govt. as 50:50 for the supplementary nutrition and 60:40 for the Non-Nutrition Component.


